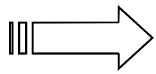

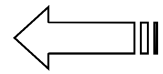

In August 2009, the Ohio Department of Education announced the gradual elimination of elective credit for high school JROTC participation. This was based on an interpretation of a course standardization bill signed into law several years ago and was done with little input from stakeholders - including high school administrators, students and their parents, JROTC instructors and veterans groups that have long supported JROTC. This would have resulted in elimination of JROTC from High Schools, leaving Ohio as the only state with no JROTCs. Efforts are underway to get a legislative fix through both the Ohio house and senate by the end of January 2010, when 8th graders start looking at scheduling HS classes. CPT Pollauf will share his experiences and update us on current Ohio House and Senate Bills to correct this DOE action. Your board has urged local representatives to co-sponsor these bills. Governor Strickland has stated he will sign the final bill.

After six years enlisted Navy service, CPT Pollauf entered University of Toledo where he received a BA and a commission as 2nd LT via senior ROTC. In 1996 he retired from a career in Armor/Cavalry. He has served as JROTC Senior Army Instructor at Western Hills (Cincinnati) and as Commandant at Harlan Academy (Chicago) prior to becoming JROTC Senior Army Instructor at Western Brown HS in Mt Orab, Ohio.

Please join us also to recognize some of the JROTC units that we support and hear brief remarks by a cadet from each program.

## WHAT IS MOAA –TOPS PROGRAM ALL ABOUT?

The Military Association of America (MOAA) has a program named The Officer Placement Service (TOPS) designed to assist the retired or retiring officer in locating a position in the civilian world. It is a national program which has a network at each of the states level to assist.

The career center located in Washington, DC is the focal point of this activity at the national level Staffed with Full-time career counselors that are ready, willing and able to assist all transitioning officers into new positions. Services available through the center include free publications, career counseling, resume critique, career center online activities, career fairs, nation-wide lectures as well as nation-wide networking contacts.

One of the most used free publications is entitled "Marketing Yourself for a Second Career. This publication is 72 pages of valuable information on obtaining a new or different position. It includes 5 chapters (Decisions, Decisions, Putting Yourself on Paper, The Power of the People, Expanding Your Job Search, and The Ultimate Thrill) plus an appendix of must have and read for the officer who is seriously looking for a position.

Counseling services are available in the new Alexandria, VA office that provides service in the Pentagon. Others have access to this system by phone (1-800-234-6622), e-mail, or on MOAA's Career Center ([www.moaa.org/career](http://www.moaa.org/career)) online system. Job board, employer links, career fair links, links to transition sites for transition services/information as well as informational networkers links are some of the resources you will see.

Resumes are a vital part of a job search activity. TOPS career center will critique theses as requested and examples are in the booklet appendix as previously mentioned. Resumes are posted on the MOAA –TOPS job board as well as searches available by Employers. There are 200-300 daily postings a week and are retained for up to 30 days to keep them current. Usually there are 3,000 in the data bank at any one time. Employers can post jobs as well as MOAA TOPS and Employers can search them. This is a free service of the Job board.

As far as the Social Media, MOAA is on LinkedIn. There is a group of over 1200 members on the MOAA Career Networking. The address is LinkedIn at [www.linkedin.com](http://www.linkedin.com). This will connect you to the interconnected network of experienced professionals. ## **AUXILIARY CORNER (A Small Piece of History)**

When I learned we were beginning construction of the first Washington State veterans' cemetery here in Spokane County, I decided to contact a group of volunteers at Arlington National Cemetery, VA., whose mission is to support military families in their greatest time of need and ensure no servicemember ever is buried alone — and all are buried with honor. These volunteers are known as the Arlington Ladies, and I thought a similar program would be appropriate in Washington state to honor those who have sacrificed so much for our country. I had the opportunity to shadow an Army Arlington Lady in July and was moved and humbled by her selfless service.

It was a warm and breezy summer day in our nation's capital when a servicemember in dress uniform came to the administration building at Arlington National Cemetery to escort the Arlington Lady to one of 22 burials that would take place that day. Funerals usually split among a number of Arlington Ladies who represent the Army, Navy, or Air Force at funerals, which means the ladies might attend six to 10 funerals on any given day.

Each branch of the military has its own group of Arlington Ladies that attends services for members of their respective branch. The exception is the Marine Corps, where the commandant of the Marine Corps sends a representative on his behalf to Arlington for all Marine funerals.

The Air Force Arlington Ladies were formed in 1948 when the Air Force chief of staff at the time and his wife noticed several airmen being laid to rest at Arlington Cemetery with only a chaplain presiding and a final salute from the honor guard. In an effort to make sure no airman was ever buried alone, the Air Force Arlington Ladies began attending funeral services. The Army Arlington Ladies was formed in 1972, followed by the Navy in 1985.

This small piece of history, which remains a current practice, is one of those traditions that reminds us the importance of selfless service and how we can each contribute to and make a difference for those who have served this country and often have paid the ultimate price.

### **VETS BONUSES ABOUT A YEAR AWAY**

Voters gave an emphatic thumbs-up to Issue 1, which will provide at least \$106 million in bonuses to an estimated 206,066 Ohio veterans or the surviving families who would qualify for them. With 99 percent of the state's votes counted, 72 percent approved the bonuses, while 28 percent rejected them. Each qualifying veteran or surviving family could receive a one-time bonus of as much as \$1,000.

Veterans who served in the Persian Gulf War, Iraq and Afghanistan and the surviving families of those who died shouldn't expect to receive the one-time bonuses Ohio voters approved for them Tuesday for at least a year.

After the election results are certified, several time-consuming steps must be taken before checks can be mailed out. At that point, veterans can begin applying for the bonuses. The applications will be screened to confirm military active duty status, time served in the Persian War, Iraq and Afghanistan, service locations and other information.

### **OIC—ANOTHER BIG CHALLENGE**

Since November 2004, we have made 20 shipments totaling 2478 school kits distributed to school children by U. S. troops in Iraq and Afghanistan.

We have just received a \$2,000 challenge from a non-member supporter of Operation Iraqi Children—the school kits project. All new donations will be matched dollar for dollar until the entire amount is matched. In light of this, we are planning a major packing effort for February (takes time to get all the supplies). With a full match, we will get very close to the 3,000 kit mark—not bad when our goal at the beginning was 30 kits!

### CONGRESS APPROVES MOAA FEDERAL CHARTER

On Oct. 27, the U.S. House of Representatives approved legislation granting a federal charter to MOAA. The Senate passed an identical bill on September 24th. The bill will now go to the President for signature. The Charter provides federal recognition of MOAA's service mission and ensures that MOAA leaders in all states can serve on state-level veterans' advisory panels.

Ohio's RC requires more than a federal charter to be a member of this committee. HB 350 was introduced by state representative Ujvagi. The purpose of the bill is to revise membership of the veterans advisory committee to assist the department of veterans services. Specifically this will add MOAA to the membership, the only purpose of the bill. This has been in the works for some time to give us a "seat at the table".
