These Military Medical Facilities Will Stop Seeing Retirees and Military Family Members

Approximately 84,000 active duty family members and 110,000 military retiree beneficiaries will be impacted by military treatment facility (MTF) downsizing proposed in a DoD report to Congress released Feb. 19.

In a phone call the morning of the release, senior DoD officials assured MOAA and other advocacy groups they are committed to maintaining access to care for all beneficiaries via a deliberate process and robust analysis of civilian TRI-CARE network capacity. However, MOAA remains concerned about the potential impacts on military families, retirees and their families, and survivors.

TRICARE Users Get Discounts on Chiropractic Care, Gym Memberships in New Pilot

The latest Tricare pilot program meant to provide better care and reduce costs has come to Atlanta, Georgia as TRI-CARE partners with Kaiser Permanente.

Nearly 1,760 Tricare beneficiaries signed up during open enrollment last year for the health care pilot that will be available for three years. That is about 740 people short of meeting the program's initial goal.

Tricare officials are testing out partnerships like this so they can move to a value-based system instead of a volumebased program that reimburses health care providers by the amount, not quality, or care they provide.

"This model can fragment the delivery of health care and inadvertently reward providers for providing low value tests, services, or procedures that are not correlated with positive health outcomes," a Tricare document said.

Welcome Aboard, US Space Force

Welcome to the 8th Uniformed Service! The United States Space Force (USSF) is now in existence as the space operations service branch of the US Armed Forces. The National Defense Authorization Act of 2020 made it an independent branch on 20 December 2019.

The USSF is organized as a military service branch within the Department of the Air Force and is headed by the Secretary of the Air Force, who reports to the Secretary of Defense.

Currently there are 16,000 individuals assigned to the Space Force with more from the Air Force, Army, and Navy expected to be added in the next three fiscal years.

Until it develops its own uniforms, members will be wearing the Air Force service dress uniform.

LtCol Brad Hamant, our Chapter's Air Force Service Representative, will be covering news of the USSF, at least until USSF officers join our Chapter ranks.

USPHS Commissioned Corps Ready to Take on Coronavirus

As the number of people around the world infected with coronavirus continues to climb, U.S. Public Health Service Commissioned Corps officers are prepared to combat the virus on the home front.

Since Monday, Commissioned Corps officers have worn their operational dress uniforms to convey their readiness to take on missions in the U.S. to fight coronavirus, and they will do so until the threat is eradicated or significantly diminished.

"All of our officers are in their operational dress uniforms because we ... are all ready to deploy as necessary. Right now, it's a relatively limited deployment, although in very important roles," said Assistant Secretary for Health Adm. Brett Giroir, the Commissioned Corps' topranking officer, in an interview with MOAA.

"It's changing on a daily basis, and we stand ready to deploy as needed."

As America's health responders, the Commissioned Corps' current missions related to coronavirus include supporting the return of American citizens from China, assisting the Centers for Disease Control and Prevention (CDC) with airport screenings to monitor the health of travelers, and working in the Department of Health and Human Services secretary's operations center.

Get Smart on the New SECURE Act

By now you may have heard of the 'Setting Every Community Up for Retirement Enhancement' (SECURE) Act, which a local financial columnist called "...one of the biggest pieces of retirement legislation this country has seen in over a decade...". What is the SECURE Act and how does it affect you?

Congress passed the Act last year to amend existing law regarding retirement planning.

In my opinion, it is a mixed bag, but you decide:

- 1. Good news. The age limit for contributions has been eliminated, so you may contribute to your traditional IRA past the age of 70.5, assuming you have qualifying income, such as wages.
- 2. Good news for some. Required Minimum Distributions (RMD's) now must start in the year you reach age 72, vice 70.5, but this change does not apply to those who turned 70.5 in 2019 or before.
- 3. Not such good news. Beginning 1 January 2020, your children or grandchildren (but not your spouse) must take all distributions from the IRA they inherit from you within 10 years or face a 50% tax penalty. Previously they could stretch the distributions over their lifetimes and see their balances grow tax-deferred.

If any of these changes apply to you, spend some time getting smart on the new SECURE Act.

Do You Need a CV Instead of a Resume?

There tends to be a fair bit of confusion among job seekers about what a CV is and when to use one when pursuing employment.

CV is short for "curriculum vitae," which in Latin means "course of life." CVs and resumes are both used for seeking employment; each provides a brief account of a person's education, qualifications, previous professional experience, achievements, awards, honors.

However, there are some differences: The CV goes into much greater depth and detail than a resume, and as a result of the greater detail and information, a CV can be considerably longer.

So, how do you know which format to use? It's actually pretty straightforward.

Just as resumes, there is no set format for CVs. You'll have a lot of latitude in deciding how you want your CV to look and feel. Whatever format your ultimately choose, though, should be constructed in a way that clearly conveys the required information. Be consistent in how you present information from section to section, and always check for spelling and grammar errors. It's a best practice to have objective readers (Such as MOAA's Career transition specialists) review your draft CV to catch mistakes you may have missed.

Ohio Veterans Hall of Fame Seeking Applications

The Ohio Veterans Hall of Fame is accepting nominations to recognize those who served in the U.S. Armed Forces and continue to contribute to our communities, state, and nation through exceptional acts of volunteerism, advocacy, professional distinction, public service, or philanthropy.

Each year, the Hall of Fame inducts up to 20 former service members based on recommendations from an Executive Committee of veterans from throughout the state and approval from the Governor of Ohio.

To be considered, the veteran must meet the following criteria:

- Be a past or current Ohio Resident
- Have received an honorable discharge
- Be of good moral character

This Hall of Fame sets the standard for recognizing Ohio's veterans for accomplishments beyond their military service. In addition, it is a fitting way to say "thank you for your service to our nation and thank you for your continued service to our communities." Chances are you know a veteran who deserves to be inducted into the Ohio Veterans Hall of Fame. You are encouraged to nominate that deserving veteran today.

ODVS Workforce Team Expands Reach in 2020

Columbus - The Ohio Department of Veterans Services continues to make an impact on helping to facilitate opportunities for veterans in Ohio's workforce - and the results speak to those efforts. According to the the U.S. Bureau of Labor Statistics, veteran unemployment in Ohio consistently has been lower than 4 percent over the course of the last year.

ODVS has a three-person Veterans Workforce Team of former service members who are effectively train and educate recruiters, hiring managers, and HR professionals who are interested in identifying, hiring and retaining veterans. The free trainings bridge the gap on military culture, teach employers how to wade through military resumes (as well as acronyms and jargon), and explain how military skills translate to civilian jobs. They also delve into topics such as veteran benefits and resources, attention to mental health, the role of military spouses, and perceived stereotypes and myths.


